


**Description:** The subject vehicles are equipped with a plastic fuel tube which could move and rub against a brake line and develop a fuel leak.

A fuel leak in the presence of an ignition source could increase the risk of fire.

**Remedy:** For all involved vehicles, Toyota dealers will replace the fuel tube with an improved part and additional clamps FREE OF CHARGE to customers. Toyota is currently preparing the remedy parts for this recall. As a temporary measure until final remedy parts are available, the dealers will install protective materials and a clamp on the fuel tube FREE OF CHARGE. At this time, Toyota expects the temporary measure will be available in November 2023. Owners will be notified by Toyota when the temporary measure is available.
